FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of Administration** assume that whatever agency utilizes the proposed contract will defray the costs of purchases from this contract, and therefore, there is no fiscal impact on Office of Administration.

Officials at the **Department of Economic Development**, the **Joint Committee on Administrative Rules** and the **Office of State Treasurer** each assume there is no fiscal impact to their respective agencies from this proposal.

Officials at the **Department of Natural Resources** assume that since the contracting language is limited to only events that commemorate capitol and state anniversaries, Missouri State Parks would not interpret the language to prevent the sale of items currently sold by the State Museum within the State Capitol. Therefore, the Department would not anticipate any direct fiscal impact to Missouri State Parks revenue.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.
