#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Platte County Board of Election Commission** assume no fiscal impact from this proposal. However, each of their sewer districts could incur costs up to approximately \$9,000 for related election expenses.

Officials at the **Department of Natural Resources**, the **Department of Economic Development's Public Service Commission** and **Office of Public Counsel**, and the **Office of the Secretary of State** each assume no fiscal impact to their respective agencies from this proposal.

Officials at the City of Kansas City, the City of Columbia, the Kansas City Board of Election Commission, the St. Louis County Board of Election Commission and the Metropolitan St. Louis Sewer District each assume no fiscal impact to their respective organizations from this proposal.

**Oversight** assumes this proposal is permissive in nature and would have no local fiscal impact without action by the governing body and approved by the majority of voters. Therefore, Oversight will reflect a \$0 impact to Local Political Subdivisions.
