FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri Senate**, the **Missouri House of Representatives** and the **Joint Committee on Administrative Rules** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from Legislative Research (LR) assume this proposal would make a requirement to have a concurrent resolution passed by both chambers. This would mean LR could not print a supplement this fall if the bill passes and is signed. Also, the requirement to "immediately" publish annotations online would require an additional FTE/staff attorney to constantly track online court decisions. Making the online version of the statute the "official" version also raises issues of authentication that involve computer encryption programs we have not fully investigated. At a minimum, LR would need an additional FTE for computer programming. Rough estimates of the authentication software involved could cost as much as \$125,000 (one-time charge).

Oversight assumes LR is provided with core funding to handle a certain amount of activity each year. Oversight assumes LR could absorb the some of the FTE and computer costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, LR could request funding through the appropriation process.

Since Oversight assumes some of the cost for this proposal could be absorbed by LR, Oversight will assume a negative impact up to the Legislative Research software cost estimate. Oversight assumes the start up cost of the computer equipment would only occur in FY 2015.
