FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education (DESE)** assume the fiscal burden appears to be on the local school districts. DESE defers to the school districts regarding the extent of any cost.

Officials from the **Fulton School District**, the **Special School District of St. Louis County**, and the **Kansas City Public School District** assumed no direct fiscal impact to their respective school districts.

In response to the introduced version of this proposal, the **Parkway School District** and the **Francis Howell School District** each assumed no fiscal impact.

Oversight assumes fiscal impact, if any, associated with this proposal will be minimal and can be absorbed with existing resources.

Officials from the following school districts: Blue Springs, Branson, Caruthersville, Charleston R-I, Cole R-I, Columbia, Fair Grove, Harrison R-IX, Independence, Jefferson City, Johnson County R-7, Kirksville, Kirbyville R-V, Lee's Summit, Malden R-I, Malta Bend, Mexico, Monroe City R-I, Nixa, Pattonville, Raymore-Peculiar R-III, Raytown, Riverview Gardens, Sedalia, Sikeston, Silex, Spickard R-II, Springfield, St Joseph, St Louis, St. Charles, Sullivan, Warren County R-III, and Waynesville did not respond to **Oversight's** request for fiscal impact.

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.
