FISCAL ANALYSIS

ASSUMPTION

Section 290.230, RSMo. - Volunteer Workers on Public Works Projects

Changes in this proposal would allow a worker on a public works project who agrees in writing to work without pay to be excluded from prevailing wage requirements. Persons in a correctional facility or performing community service under the terms of a criminal proceeding could not be considered volunteers for the purposes of this proposal, and employers could not coerce employees to volunteer.

Officials from the **Office of the Secretary of State**, the **Joint Committee on Administrative Rules**, the **Office of Administration - Office of the Commissioner and Division of Budget and Planning**, and the **Department of Labor and Industrial Relations** each assume this proposal would have no fiscal impact on their organizations.

Officials from **Cole County**, **St. Louis County**, and the **St. Louis County Directors of Elections** each assumed a previous version of this proposal would have no fiscal impact on their organizations.
