ASSUMPTION

Officials from the **Department of Insurance, Financial Institutions and Professional Registration**, the **Department of Mental Health**, and the **Department of Social Services (DOS)** each assume the current proposal will not fiscally impact their respective agencies.

Officials from DOS also stated that currently law, Section 337.603(2), RSMo, provides a licensing exemption for social workers employed by an agency or department of the state of Missouri while discharging the person's duties in that capacity.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
