#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Social Services - Children's Division** do not anticipate any fiscal impact from the repeal of this prohibition.

Officials from the **Office of State Courts Administrator** anticipate no fiscal impact on the Courts.

Officials from the University of Missouri System, Linn State Technical College, and Missouri State University each state this proposal has not financial impact on their respective institutions.

Officials from the **Joint Committee on Administrative Rules (JCAR)** state this proposed legislation is not anticipated to cause a fiscal impact to JCAR beyond its current appropriation.

In response to the introduced version of this proposal, the following responses were received:

Officials from the **Department of Higher Education (DHE)** assumed this bill would repeal the prohibition on a quality rating system for early childhood education that is not established through Missouri statute. Since the bill only deletes a current prohibition and does not mandate any action by the DHE or any public college or university, the proposal would have no direct fiscal impact on the DHE or public higher education in Missouri.

Officials from the **Department of Elementary and Secondary Education** stated this proposal will have no fiscal impact on their agency or on school districts.

Officials from the **Office of Attorney General** assumed any potential costs arising from this proposal can be absorbed with existing resources.

Officials from the following agencies anticipated no direct fiscal impact on their respective agencies: Missouri House of Representatives, the Department of Health and Senior Services, the Missouri Senate, and the Department of Revenue.

According to officials from the **Office of Secretary of State (SOS)**, many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS's office is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact

for this fiscal note to Secretary of State's office for Administrative Rules is less than \$2,500. SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what their office can sustain with their core budget. Therefore, SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal with core funding. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Officials from the University of Central Missouri, Northwest Missouri State University, and Missouri Western State University, anticipated no fiscal impact on their respective institutions of higher education.

Officials from the following colleges and universities: Crowder, East Central Community College, Harris-Stowe, Jefferson College, Kansas City Metro Community College, Lincoln University, Moberly Area Community College, Missouri Southern State University, Southeast Missouri State University, State Fair Community College, St. Charles Community College, St. Louis Community College, Three Rivers Community College, University of Central Missouri, University of Missouri System, and Truman State University did not respond to **Oversight's** request for fiscal impact.
