#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Office of the Secretary of State** assume to meet the requirements of this proposal, programming changes will be made with the centralized voter registration database and military portal to incorporate these new categories of voters with an estimated one time cost of \$15,400.

Officials at the **Kansas City Board of Election Commission** assume the impact of this proposal to their operations would be minimal.

Officials at the St. Louis County Board of Election Commission, Lincoln County Clerk's Office, the Platte County Board of Election Commission, Buchanan County Clerk's Office, St. Francois Clerk's Office, the St. Louis City Board of Election Commission, and the Jackson County Board of Election Commission each assume no fiscal impact from this proposal to their respective organizations.

Officials at the Clay County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.
