FISCAL ANALYSIS

ASSUMPTION

Due to time constraints, officials from the **Office of the State Courts Administrator (OSCA)** estimated the impact of the three surcharges in this proposal would be under \$100,000 for each, but over \$100,000 in additional revenue, collectively.

§488.2244 - Jasper County

Oversight does not have information regarding the number of civil and criminal cases filed in the 29th judicial circuit that this new \$10 surcharge would apply to. Therefore, Oversight will utilize OSCA's "under \$100,000" of impact estimate.

§488.2257 - Howell County

In response to a previous version of this proposal, officials at **Howell County** assumed a projected income of \$60,000 with no or nominal expense to the county.

Officials at the City of West Plains did not respond to **Oversight's** request for fiscal impact.

The Senate Substitute added civil cases that the \$10 surcharge would apply to. **Oversight** will utilize the estimate from Howell County.

§488.2258 - Regional Juvenile Detention Districts

Again, **Oversight** does not have information regarding the number of cases that this new \$1 surcharge would apply to. Therefore, Oversight will utilize OSCA's "under \$100,000" of impact estimate.

Bill as a whole

Oversight assumes the surcharges will be paid by the defendant and will therefore have no fiscal impact to the state from this legislation.

Officials at the **Office of the State Treasurer** assume no fiscal impact from this proposal.

Officials at the following counties: Bollinger, Cape Girardeau, Christian, Cole, Jasper, Maries, Montgomery, New Madrid, Ozark, Perry, Pulaski, St. Francois and Wayne did not respond to **Oversight's** request for fiscal impact.

FISCAL DESCRIPTION

This proposal creates in the state treasury the "Jasper County Judicial Fund". The moneys shall be used to pay for the costs associated with the purchase, lease, and operation of a county juvenile center and county judicial facility.

This proposal also provides that the court shall, upon adoption of an ordinance, assess a surcharge of up to ten dollars for civil and criminal cases filed in Howell County. The surcharge shall not be assessed when the case has been dismissed or if the court costs are to be paid by the state, county, or municipality. The money collected shall be used by the county to pay for the land assemblage and purchase, construction, maintenance, and upkeep of a county justice center.

Finally, this proposal also provides a surcharge of one dollar to be assessed as costs in each court proceeding filed in any court in the state located in a regional juvenile detention district.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
