FISCAL ANALYSIS

ASSUMPTION

§ 640.090 - Department of Natural Resources Implementation Impact Reports:

Officials from the **Department of Natural Resources (DNR)** assume this proposal would require an implementation impact report for all state implementation plans (SIPs), state plans, rules, or regulations prepared for submission to the U.S. Environmental Protection Agency (EPA) based on Clean Water and Clean Air Act regulations.

DNR assumes this proposal would require additional staff work in preparing an implementation report for additional rules and plans where this type of analysis is not currently required and answering the specific criteria of the implementation report. Currently, DNR relies heavily on extensive stakeholder involvement to ensure DNR is considering such impacts well in advance of proposing a rule or other major action. DNR does not currently have staff with the expertise necessary for preparing the implementation impact report required in this proposal.

DNR assumes 10 additional FTE would be required to address this new requirement. The additional technical staffing need is estimated based on the current level of effort to prepare a regulatory impact report (RIR) for any rule that prescribes an environmental condition or standard (required by 640.015, RSMo). The preparation time for these rulemaking RIRs is estimated at approximately 150 hours each. It is anticipated the new requirement for implementation impact reports will triple the amount of preparation time and effort, or roughly 450 hours each, due to the more in-depth analysis and coordination with other agencies required.

DNR anticipates the additional expenses to begin July 1, 2015 (FY16). The total additional expenses would result in an estimated fiscal impact of \$782,822 in FY16. DNR assumes the proposal does not provide a funding source and the department currently has no funds available for additional work as existing fees are not covering current year expenditures. DNR assumes General Revenue funds would be required to implement the proposal with the following costs.

§ 640.090 - Department of Natural Resources Implementation Impact Reports:

This proposal requires the Department of Natural Resources, when developing a state implementation plan, state plan, rule, or regulation for submission to the Environmental Protection Agency, to prepare an implementation impact report. The report shall contain certain criteria as set forth in the proposal, and shall be delivered to the Governor, President Pro Tempore of the Senate, and the Speaker of the House of Representatives along with the proposed plan, rule, or regulation one month prior to submission to the Environmental Protection Agency. The report and proposed plan, rule, or regulation shall also be posted to DNR's website.
