ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

In response to other highway naming bills from this year, officials from the **Department of Transportation** assumed no fiscal impact to their organization.

Oversight assumes this proposal will have no fiscal impact on state or local governments.

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.
