## FISCAL ANALYSIS

### ASSUMPTION

In response to other highway and bridge naming bills from this year, officials from the **Department of Transportation** assumed no fiscal impact to their organization.

**Oversight** assumes the numerous sections require a fee, to be collected by the Highways and Transportation Commission, or private donations to cover the cost of constructing and maintaining the proposed interchange, bridge or highway signs. Oversight assumes this proposal will have no net fiscal impact to state or local governments.

### FISCAL DESCRIPTION

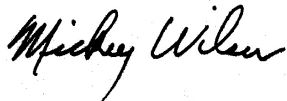
The proposed legislation appears to have no direct fiscal impact.
