FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Labor and Industrial Relations**, the **Office of the State Courts Administrator**, the **Office of Administration** and the **Missouri Department of Conservation** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Department of Transportation** did not respond to our request for fiscal impact.

Officials from the **City of Kansas City** assume this proposal may result in additional cost but is unlikely. The City has almost no cases related to pay disparity. The labor side of the City's employment structure utilizes a seniority system and the pay structure for exempt employees is designed to utilize a certain set percentage increase based on job performance, without regard to gender.

Oversight assumes any potential cost arising from this proposal can be absorbed with existing resources.
