## **ASSUMPTION**

Officials at the **Department of Elementary and Secondary Education** and the **Malta Bend Schools** each assume there is no fiscal impact to their respective organization from this proposal.

Officials at the **Kansas City Public Schools** assume an impact of less than \$10,000.

Officials at the **Everton R-III School District** assume a cost of \$4,000.

**Oversight** assumes this proposal requires that current health classes teach about sexual predators, online predators and the consequences of inappropriate texting. Oversight assumes school districts should be able to include this information in their current health courses and would not have any additional fiscal impact.
