#### FISCAL ANALYSIS

#### **ASSUMPTION**

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Oversight notes this proposal appears to be very similar to HB 672 from the current session. In response to that proposal, officials from the Department of Social Services (DSS), MO **HealthNet Division (MHD)** stated if the proposed legislation is enacted MHD would reimburse for behavior assessment and intervention codes 96150 to 96154 for all psychologists regardless of any accreditation or specific training. MHD does not currently reimburse for these codes for psychologists without specific training in this intervention, therefore, a cost would be incurred. MHD anticipates the reimbursement for these codes would be \$20.00 per unit. Medicare does reimburse for codes 96150 to 96154 and MHD pays for the Medicare deductible and coinsurance related to these codes for dual (Medicare and Medicaid) enrolled individuals. In FY 2014, MHD paid the coinsurance and deductibles on 1,635 units of service. The number of dual enrolled participants in December 2014 was 144,926. The number of claims billed per dual enrolled is 0.011 (1,635 / 144,926). The number of MHD participants who are eligible for these services covered by codes 96150 to 96154 was 726,940 in December 2014. The estimated number of units which would be billed to MHD is 7,996 (726,940 X 0.011 claims/dual enrolled) annually. The estimated FY 2014 cost would be \$159,920 (7,996 x \$20.00). The FY 2014 cost was inflated by 1.9% annually to arrive at the FY 2016 through FY 2018 cost.

The proposed legislation has an emergency clause and will begin July 1, 2015.

Since this legislation is subject to appropriation, the cost is stated as a range.

FY16: Total \$0 to \$166,054 (GR \$0 to \$60,904; Federal \$0 to \$105,150);

FY17: Total \$0 to \$169,209 (GR \$0 to \$62,061; Federal \$0 to \$107,148); and,

FY18: Total \$0 to \$172,424 (GR \$0 to \$63,240; Federal \$0 to \$109,184).

In addition, officials from the **Department of Health and Senior Services (DHSS)** and the **Department of Mental Health (DMH)** each assumed the proposal would not fiscally impact their respective agencies.

Therefore, **Oversight** presents this fiscal note with the information and costs provided by DSS-MHD, DHSS, and the DMH.

### FISCAL DESCRIPTION

This proposal provides that, subject to appropriations, MO HealthNet providers of behavioral, social, and psychophysiological services, including psychologists, shall be reimbursed for the prevention, treatment, or management of physical health problems.

This proposal contains an emergency clause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
