#### FISCAL ANALYSIS

#### ASSUMPTION

Officials from the **Department of Corrections**, the **Department of Public Safety - Missouri Veterans Commission** and the **Department of Revenue** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Department of Revenue (DOR)** state in FY `14 there were 84 God Bless America license plates issued where a onetime \$10 donation to the World War II Memorial Trust Fund was collected resulting in \$840 to the fund.

**Oversight** assumes, for fiscal note purposes only, there will be the same number of applicants, making the \$10 contribution in future fiscal years. This would result in a shift of revenue from the World War II Memorial Trust Fund to the World War I Memorial Trust Fund in the amount of \$700 in FY `16 (10 months) and \$840 in FY `17 and FY `18.
