#### FISCAL ANALYSIS

#### **ASSUMPTION**

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

In response to similar legislation filed this year (HB 212), officials at the **Office of the Secretary of State** assumed this proposal would require the Governor, if at the time the vacancy occurs there is one year or more remaining in the unexpired term, to issue a writ of election within thirty days of receiving the certification of vacancy. Due to the un-predictability of when vacancies occur and the geographical size of the vacated district, costs associated with this proposal are difficult to estimate. In previous county wide elections, where one race is on the ballot, costs have varied from \$6,058 to \$275,000 per election.

Officials at the **Lincoln County Clerk's Office** assume this proposal has the potential to cost Lincoln County up \$35,000 to \$65,000 per instance that an election is ordered. That is based upon the cost of the County holding a county wide election when there is otherwise no county wide issue from the County on the ballot. If the election is ordered during an August Primary or a November General Election, there would be no additional cost to the County.

Officials at the **Platte County Board of Election Commission** assume the costs of a single issue election are up to \$65,000 for a county wide election (i.e. Presiding Commissioner).

Officials at the **Office of the Governor**, the **Jackson County Clerk's Office**, and the **St. Louis County Board of Election Commission**, assume no fiscal impact to their organization.

**Oversight** assumes that currently if a vacancy occurs in the county commissioner seat, the Governor appoints a new commissioner. This proposal will require the vacancy to be filled at the next regular election if a year or more remains of the commissioner's term. Oversight assumes that should this occur, the local election authorities can absorb this cost with current election expenses.
