### ASSUMPTION

**Oversight** has not received a response from any county regarding this proposal.

#### § 643.650 - Sulfur Dioxide Air Quality Monitoring:

Officials from the **Department of Natural Resources (DNR)** assume this proposal indicates the owner of the electrical utility would be responsible for electing which method is used to characterize the source's Sulfer dioxide impacts and it is assumed that the owner is also responsible for purchasing the equipment, operations, and maintenance costs of the network.

DNR would not anticipate a direct fiscal impact from this proposal.

Officials from the **Department of Economic Development** and **Department of Health and Senior Services** each assume the proposal would not fiscally impact their respective agencies.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
