FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Officials at the **Department of Elementary and Secondary Education (DESE)** assume there would not be an increased cost to the state. This legislation just delays the implementation of adjusting the state adequacy target if the formula is underfunded.

Oversight notes this proposal beginning on July 1, 2017, would require DESE, if the foundation formula is not funded, to adjust the state adequacy target. Oversight notes that DESE and the Office of Administration's Division of Budget and Planning were not able to provide Oversight with a projection of when the foundation formula may be fully funded. Oversight assumes this would not fiscally impact the state.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

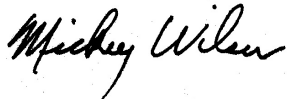
FISCAL DESCRIPTION
