FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

§§ 266.301, 266.311, 266.331, 266.336, 266.343, 266.347 - Fertilizer Control Board:

Oversight assumes this proposal limits the total penalties that can be assessed to a fertilizer distributor to no more than \$5,000 per year, or the amount of the current value of the plant food deficiency, whichever is greater.

Oversight assumes a fertilizer distributor, who knowingly violates the provisions of law relating to fertilizers, could be assessed a penalty of not more than \$25,000 for each offense. At this time, Oversight will show no direct fiscal impact to the University of Missouri Agriculture Experiment Station.

Officials from the **Department of Natural Resources** assume the proposal would not fiscally impact their agency.

FISCAL IMPACT - Small Business

§266.343 - Penalties Assessed to a Fertilizer Distributor:

Small business fertilizer distributors could expect to see penalties not exceed \$5,000 per year or the amount of the current value of the plant food deficiency, whichever is greater for a violation; and no more than a \$25,000 penalty if the distributor knowingly violates the provisions in sections 266.291 to 266.351.

FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
