FISCAL ANALYSIS

ASSUMPTION

Due to time constraints, **Oversight** originally prepared a fiscal note for this bill without all of the agency responses. Oversight has since obtained the agency responses and upon review of those responses, believes the original fiscal note should be updated. Therefore, this fiscal note updates the original by providing agency responses.

Officials at the **Office of the Governor** assume §41.1012 establishes the Office of Military Advocate; the military advocate is a gubernatorial appointee. There should be no added cost to the Governor's Office as a result of this measure. However, if additional duties are placed on the office related to appointments in other TAFP legislation, there may be the need for additional staff resources in future years.

Officials at the **Department of Economic Development (DED)** assume §41.1012 creates the Office of Military Advocate which will employ a person appointed by the Governor with advice and consent of Senate to help advocate for military services and bases in Missouri. The proposal requires the office be housed within DED and DED is responsible for providing necessary staff. DED assumes 2 additional FTE will be required as a result of this proposal. A Community and Economic Development Manager Band 2 will serve as the military advocate. An administrative office assistant will serve as an aid for the military advocate.

FISCAL DESCRIPTION


This bill creates the Office of Military Advocate within the Missouri Military Preparedness and Enhancement Commission for the purpose of advocating for the military in Missouri. The office will be administered by the military advocate, who will be appointed by the Governor with the advice and consent of the Senate. The advocate will serve a term of six years and the Department of Economic Development must provide administrative support and staff as needed to support the office.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
