### FISCAL ANALYSIS

### ASSUMPTION

Officials at the **Missouri Ethics Commission** (**MEC**) assume §105.453.1 would prohibit any member of the General Assembly from accepting or receiving compensation of any kind as a paid political consultant (defined in Sec. 105.450(8)) until a specified amount of time after expiration of any term of office for which such member is elected.

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in Section 105.491, 105.955.14 (4), RSMo, about the new statutory requirements; examples include providing education, developing informational materials, and fielding telephone and email questions.
- Provide oversight in adherence to the specific prohibition of receiving compensation as a political consultant from the entities outlined in 105.456, including reviewing campaign finance reports as established in Section 105.955.14 (2), (3), RSMo.
- Respond to written complaints, as established in Section 105.955.14, RSMo, through conducting investigations and any legal actions arising from those investigations. Any significant increase in complaints would require additional Commission resources, including investigative staff.

It is assumed this proposal would result in a minimal number of complaints; however, if this assumption is incorrect the Commission would require additional staff resources.

**Oversight** assumes that should MEC see an increase in complaints to justify additional staff resources, they will seek those resources through the appropriation process.
