#### FISCAL ANALYSIS

#### ASSUMPTION

In response to a previous version, officials from the **Department of Revenue (DOR)**, the **Missouri Department of Conservation (MDC)**, the city of **Kansas City**, the **St. Louis County Directors of Elections**, **Callaway County**, **Platte County** and the **Jackson County Election Board** assumed no fiscal impact on their respective organizations.

In response to a previous version, officials from the **Office of Administration - Budget and Planning (B&P)** assumed no fiscal impact. B&P noted this proposal would exempt internet and e-mail access from state and local sales and use tax, and further stated these are currently exempt from sales and use tax under federal law. Further, this proposal has no impact on Total State Revenue and is not subject to Article X, 18(e) calculations.

In response to a previous version, officials from the **Department of Natural Resources (DNR)** deferred to DOR and B&P for an account of the fiscal impact.

In response to a previous version, officials from the cities of **Gladstone**, **Grandview**, **Lee's Summit** and **Liberty** assumed a material negative fiscal impact based upon their reading of the language in the proposal.

Officials from the **Platte County Board of Elections** assume no fiscal impact from the proposal.

**Oversight** will use the impact statements of DOR, B&P, MDC and DNR as well as the statement from the city of Kansas City, the St. Louis County of Director of Elections, Callaway County, Platte County and the Jackson County Election Board as the basis for this no impact fiscal note.

**Oversight** has inquired with the U.S. Department of Commerce to confirm the federal law exemption but has not yet received a response to the inquiry.
