### FISCAL ANALYSIS

### **ASSUMPTION**

**Oversight** notes this proposal requires the Department of Elementary and Secondary Education (DESE) to develop a simplified annual school report card and to post the report card on the DESE website. Additionally, each school district must distribute the report card prior to each school year. Based on the responses below, Oversight assumes that school districts will have mailing costs associated with the distribution of the report card. Oversight will show the impact as Unknown greater than \$100,000 for school districts cumulatively.

Officials at **DESE** assume there is no fiscal impact from this proposal to their agency.

Officials at the **Bismarck School District** assume that mailing the information would be expensive.

Officials at the **Brentwood School District** assume \$1,000 annually for mailing the required report card.

Officials at the **Central R-III School District** assume a cost of \$2,800 if a hard copy is distributed.

Officials at the **Chilhowee R-IV** and the **Macon County R-IV** school districts each assume this would have minimal cost for printing and distribution of required information.

Officials at the **East Newton School District** assume a cost of \$1,400.

Officials at the **Eldon School District** assume a cost of \$1,900.

Officials at the **Everton School District** assume costs of \$2,500.

Officials at the **Kingston 42 School District** assume an increase in salary, supplies of \$1,000.

Officials at the **Pettis County R-XII** and the **Seymour R-II** school districts each assume costs of \$500.

Officials at the **Sarcoxie School District** assume this would cost \$1,000 for materials and labor.

Officials at the **Shell Knob School District** assume this would cost the school but the amount is unknown.

Officials at the St. Charles School District assume a cost of \$5,000 for printing and mailing.

Officials at the **West Plains School District** assume a cost of \$2,500-\$3,500 annually for postage and photocopy charges.

Officials at the Carondelet Leadership Academy, Kansas City, Parkway, Riverview Gardens, Smithville R-II, St. Elizabeth R-IV, Warren County R-III and the Wright City R-II school districts each assume there is no fiscal impact from this proposal to their respective districts.

Officials at the **Milan C-2** and the **Richland** school districts responded to Oversight's request for fiscal impact but did not indicate an impact.

Officials at the **Joint Committee on Administrative Rules** assume there is no fiscal impact from this proposal.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

## **FISCAL DESCRIPTION**

The State Board of Education shall develop a simplified annual school report card for each school attendance center. Each school, including each charter school, will be given a letter grade of A, B, C, D or F based on percentages identified in the act that corresponds to the percentage of points earned on the school's annual performance report. Alternative schools will not receive a report card unless they specifically request one. Grades will not be assigned to schools if the number of students tested is smaller than the minimum sample size necessary based on professional practices for statistical reliability. The report card shall also identify each school's performance as having improved, remained the same, or declined based on the prior year in terms of the letter grade and value.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
