## **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the **Department of Public Safety - Office of the Director (DPS)** state they see no fiscal impact due to this legislation. The fee increase will be deposited to General Revenue as they are now.

DPS states at the present time, there are no licensed Corporate Security Advisors (CSA) in Missouri. With the change in the Code of State Regulations, it was determined that all former CSAs (approximately 200) did not meet the minimum basic training requirements for licensure. The licensed training centers are working to revamp their 40 hour CSA training course and DPS hopes to start training CSA applicants shortly after the first of the year. As of right now, we have not charged any licensing fees.

**Oversight** will reflect a fiscal impact to the General Revenue Fund of \$0 (DPS chooses not raise the license fee) to a minimal amount of additional revenue. If 200 Corporate Security Officers are each charged an additional \$50 for their license, the state would receive an extra \$10,000.

# FISCAL IMPACT - Small Business

Corporate Security Officers could pay more in licensure fees as a result of this proposal.

# FISCAL DESCRIPTION

Under current law, the Department of Public Safety may charge a fee for issuance of a corporate security advisor license of up to \$200. This act raises the licensee fee to up to \$250.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
