FISCAL ANALYSIS

ASSUMPTION

Section 192.380

Oversight assumes this proposal requires Department of Health and Senior Services (DHSS) to establish criteria for levels of maternal care designations and levels of neonatal care designations for birthing facilities. Beginning January 1, 2018, any hospital with a birthing facility shall report to DHSS its appropriate level of maternal care designation and neonatal care designation as determinated by the criteria outlined under subsection 2 of this section.

Oversight assumes the requirements of this proposal could be handled by DHSS's current appropriations.

Section 197.065

In response to a similar proposal, SCS for HCS for HB 2402, officials from **Department of Health and Senior Services** assumed this provision would not fiscally impact their agency.

Section 338.200 and 338.202

In response to the previous version of this proposal, officials from the **Department of Insurance, Financial Institutions and Professional Registration** assumed the proposal would not fiscally impact their agency.

Section 376.685

In response to a similar proposal from this session, SCS for SB 830, officials from the **Department of Health and Senior Services**, the **Department of Transportation**, the **Missouri Department of Conservation**, the **Department of Mental Health**, the **Missouri Consolidated Health Care Plan**, the **Department of Social Services** and the **Department of Insurance**, **Financial Institutions and Professional Registration** each assumed the proposal would not fiscally impact their respective agencies.

Officials from the **Department of Public Safety - Missouri Highway Patrol** deferred to Department of Transportation for fiscal impact.

Section 536.031
