# **ASSUMPTION**

Officials at the **Office of the Secretary of State** and the **Office of the Governor** each assume no fiscal impact from this proposal to their respective organizations.

Officials at the Callaway County, St. Louis County Board of Election Commission, Jackson County Board of Election Commission, Platte County Board of Election Commission, Buchanan County and Christian County each assume no fiscal impact from this proposal to their respective organizations.

**Oversight** assumes the counties would see a savings due to counties appointing vacated county elected officials rather than holding a special election. Oversight will range the fiscal impact as \$0 to Unknown.

Officials at the following boards of election commissioners: Kansas City Board of Election Commission, St. Louis City Board of Election Commission, and Clay County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.

## FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

## FISCAL DESCRIPTION

Under current law, whenever any vacancy occurs in any office filled by election, other than the offices of Lieutenant Governor, state senator, state representative, sheriff, or St. Louis City Recorder of Deeds, the Governor is responsible for appointing a successor until the next election. This act modifies that provision so that vacancies in any county office of a noncharter county shall be filled by the county commission. In the event that the county commission consists of two members who cannot come to an agreement on an appointee, the presiding commissioner shall fill the vacancy.

The provisions of this act do not apply to charter counties.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
