FISCAL ANALYSIS

ASSUMPTION

In response to previous versions of the proposal, officials at the **Missouri Ethics Commission** (**MEC**) assumed §105.453 requires any current or former public official registering as a lobbyist to dissolve their candidate committee and allows funds to be returned to the contributor, donated to nonprofit entity, or transferred to candidate or political party committee.

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in §105.491, 105.955.14 (4), RSMo, about the new statutory requirements; examples include providing education, developing informational materials, and fielding telephone and email questions.
- Provide oversight in adherence to the dissolution of the committee and disbursement of the funds as outlined in §105.453, including reviewing campaign finance reports as established in §105.955.14 (2), (3), RSMo. Any significant increase in lobbyist registering with active candidate committees would require additional Commission resources, including reporting analyst staff.
- Respond to written complaints, as established in §105.955.14, RSMo, through conducting investigations and any legal actions arising from those investigations. Any significant increase in complaints would require additional Commission resources, including investigative staff.

§130.021.4.(3) and §130.034.7 requires funds of a candidate committee, campaign committee, debt service committee, or exploratory committee shall be invested in instruments allowing withdrawal without penalty in a time period of one year or less.

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in §105.491, 105.955.14 (4), RSMo, about the new statutory requirements; examples include providing education, developing informational materials, and fielding telephone and email questions.
- Respond to written complaints, as established in §105.955.14, RSMo, through conducting investigations and any legal actions arising from those investigations. Any significant increase in complaints would require additional Commission resources, including investigative staff.

\$130.097 prohibits a candidate or an individual from contributing to any other committee and then being paid by that receiving committee for any purpose.

ASSUMPTION (continued)

This change would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in §105.491, 105.955.14 (4), RSMo, about the new statutory requirements; examples include providing education, developing informational materials, and fielding telephone and email questions.
- Provide oversight in adherence of the reporting of contributions as outlined §130.097, including reviewing campaign finance reports as established in §105.955.14 (2), (3), RSMo.
- Respond to written complaints, as established in §105.955.14, RSMo, through conducting investigations and any legal actions arising from those investigations. Any significant increase in complaints would require additional Commission resources, including investigative staff

It is assumed this prohibition would result in a minimal number of complaints; however, if this assumption is incorrect the Commission would require additional staff resources.
