FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Oversight assumes that this proposal creates the offense of terrorism. The offense of terrorism is a class A felony and shall have a punishment of life without the eligibility for probation, parole, or release except by the act of the Governor. Oversight assumes there would be costs associated with this new class A felony with the Department of Corrections (DOC), however Oversight is unclear on how much the cost would be. Therefore, Oversight will assume an unknown cost for DOC for this proposal.

FISCAL DESCRIPTION

This act creates the offense of terrorism. A person commits the offense if he or she causes serious physical injury in the course of committing an act for the purpose of intimidating people, influencing government policy by intimidation, or affecting the conduct of a government. The offense is punishable by a sentence of life without parole.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
