FISCAL ANALYSIS

ASSUMPTION

Oversight was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

Oversight notes this proposal in §174.165, allows the governing boards of Central Missouri State University, Southeast Missouri State University, Missouri State University, Northwest Missouri State University, Missouri Western State University, Missouri Southern State University and the Harris-Stowe State University to have the power to offer baccalaureate and graduate degree programs, subject to the approval by the coordinating board of higher education.

Oversight notes §174.640 allows the board of governors of Truman State University to have the power to offer baccalaureate and graduate degree programs, subject to the approval by the coordinating board of higher education.

Officials at the **Department of Higher Education** state that while there is no impact to the department to process applications for new degree programs, there could be a fiscal impact to institutions to hire faculty and open new facilities to house graduate degree programs.

Oversight notes §174.225, §174.231, §174.251 and §174.324 remove the restrictions from universities offering certain degree programs. Oversight notes that if a University decides to offer a certain degree program, tuition and fees from the students should cover the expenses of offering the courses. Oversight is unable to determine which Universities may expand their degree offerings as a result of this proposal. Oversight will not show an impact to the Universities from this proposal.

Officials at the **University of Missouri** assume the immediate fiscal impact of this proposal is difficult to predict, but with the expectation that state funding available for higher education will decline in the future, it is reasonable to believe starting new graduate, professional and engineering programs at other institutions will result in a loss of state funding to the University of Missouri system and its campuses.

Officials at the **State Technical College of Missouri** assume there is no fiscal impact from this proposal on their College.

In response to a similar proposal from 2016, officials at the **Metropolitan Community College** assumed there would be no fiscal impact from this proposal on their College.

In response to a similar proposal from 2016, officials at the **Missouri State University** assumed there would be a positive fiscal impact on their College.
