### ASSUMPTION

Officials at the **Office of the State Courts Administrator** assume the proposed legislation eliminates division designations for circuit and associate courts in the Sixteenth Judicial Circuit. There may be some impact to the state as well as the county, but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

Officials at the **City of Kansas City** assume no fiscal impact from this proposal.

Officials at the City of Independence and Jackson County did not respond to **Oversight's** request for fiscal impact.

### FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.
