FISCAL ANALYSIS

ASSUMPTION

Officials at **St. Louis County (SLC)** assume the proposal will allow peddlers and solicitors to not have to register with SLC and be unregulated. SLC will lose about \$5,000 annually from this proposal.

Officials at the **Office of Administration** defer their response to the Department of Revenue.

Officials at the **Department of Revenue**, the **Office of the Attorney General**, the **Office of the State Courts Administrator**, the **Office of the State Treasurer**, the **Department of Health and Senior Services**, the **Department of Natural Resources**, the **Department of Agriculture** and the **State Tax Commission** each assume no fiscal impact to their respective agencies from this proposal.

Officials at **Boone County** assume a minimal fiscal impact.

Officials at the **Boone County Sheriff's Department** assume no fiscal impact from this proposal.

In response to similar legislation from 2016, SB 817, officials at **Jefferson County** assumed very little impact from this proposal.

There could be a direct fiscal impact to small businesses as a result of this proposal because small business peddlers would not have to obtain a license.


FISCAL DESCRIPTION
