#### FISCAL ANALYSIS

## ASSUMPTION

Officials at Legislative Research (LR) assume the following regarding this proposal:

There are currently 1,600 reserved set orders of the Revised Statutes of Missouri. LR wants to purchase 2,500 sets total, depending on vendor bids, to last until the next republication around 2025.

LR estimates the vendor cost will be \$350,000 and UPS charges will be \$20,000.

LR anticipates selling the sets for \$400 each. It is unknown at this time how many sets will be sold. Proceeds from the sale of the Revised Statutes of Missouri will be deposited into the Statutory Revision Fund (0546), which has a current balance of \$64,423.21.

LR assumes there will be no fiscal impact from this proposal.

Officials from the **Office of the State Treasurer** assume the proposal will have no fiscal impact on their organization.

#### FISCAL DESCRIPTION

This proposal modifies provisions of law relating to the duties and functions of the Joint Committee on Legislative Research.

### FISCAL DESCRIPTION (continued)

Currently, certain public officials receive free copies of the revised laws. This proposal removes that provision and states that the Committee shall distribute copies at a price determined by the Committee.

Currently, the revised statutes are reprinted and published only upon the adoption of a concurrent resolution by the General Assembly. This proposal requires the publication of the revised statutes every ten years in accordance with the Missouri Constitution. When the Committee sells copies of the revised statutes, this proposal requires that money received from such sale shall be deposited in the statutory revision fund, rather than the general revenue fund.

Under current law, the Committee is required to create one chapter of law that re-codifies existing provisions of law, including specified chapters and sections, concerning court costs, fees, and surcharges. This proposal removes references to specified chapters and sections of law.

Upon written request, the Committee is required to aid in the drafting of revision bills, including any amendments directly related to such bills or the duties and functions of the Committee. The Committee shall also establish and maintain an electronic database of all reports required to be submitted to the General Assembly, which shall be publicly accessible. Beginning January 1, 2018, all statutorily required reports shall be electronically submitted to the Committee for inclusion on the database.

Currently, the Committee is required to annually compile a report of its activities and expenditures for submission to the General Assembly. The report must include any recommendations for legislative action or the efficient and economical operation of state government. This proposal repeals these reporting requirements.

This act has an emergency clause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
