# **ASSUMPTION**

Officials at the **Office of the Attorney General (AGO)** assume this proposal gives the AGO concurrent original jurisdiction to enforce abortion laws. If there are violations of these laws, the AGO may seek injunctive or other relief. While the number of alleged or suspected violations are unknown, the AGO anticipates that 3 FTE AAG 1 are necessary to fully address the intent of this proposal. The AGO may seek additional appropriations if the need exceeds existing resources.

Officials at the Office of the State Courts Administrator, the Department of Insurance, Financial Institutions and Professional Registration, the Department of Social Services, the Department of Health and Senior Services, the Office of the State Public Defender and the Office of Prosecution Services each assume no fiscal impact to their respective agencies from this proposal.

#### FISCAL IMPACT - Small Business

## FISCAL DESCRIPTION

Under this act, the Attorney General shall have concurrent original jurisdiction throughout the state, along with each prosecuting attorney and circuit attorney within their respective jurisdictions, to commence actions for any violation of the state's abortion laws. The Attorney General, or each respective prosecuting or circuit attorney, may seek injunctive or any other relief as necessary.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
