FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Economic Development (DED)** assume section 620.2100 establishes the Schoolcraft Ozark Exploration Bicentennial Commission, a twelve-member commission charged with organizing and coordinating efforts relating to the bicentennial celebration of the exploration of the Ozarks by Henry Rowe Schoolcraft and promoting public awareness of the importance of Schoolcraft's exploration. The Director of the Division of Tourism is to be a member of the commission, and the Division of Tourism is to provide administrative support for the commission. The Division of Tourism believes that these duties could be absorbed within existing resources.

This proposal also establishes a dedicated fund (the Schoolcraft Ozark Exploration Bicentennial Fund) to reimburse commission members for their expenses. The proposal specifies that the newly-created fund may accept state and federal appropriations, bequests, gifts, fees, and awards. It is assumed that the commission will meet four times in FY 2018 and four times in FY 2019 before being dissolved on June 30, 2019. Mileage expenses for each member are estimated at \$100, and meal expenses for each member are estimated at \$20. It is assumed that overnight accommodations will not be necessary. The Division of Tourism is therefore requesting \$5,760 in FY 2018 and \$5,904 in FY 2019 (adjusted for inflation) to reimburse commission members for their actual and necessary expenses.

Officials from the Missouri House of Representatives, Missouri Senate, Office of Administration - Commissioner's Office and Missouri State University each assume the proposal will have no fiscal impact on their respective organizations.

Oversight assumes the new fund would need an appropriation from the General Revenue Fund to pay the anticipated expenses of the Department of Economic Development.

FISCAL DESCRIPTION

This act creates the Schoolcraft Ozark Exploration Bicentennial Commission, with membership as outlined in the act. The act creates the "Schoolcraft Ozark Exploration Bicentennial Fund" to hold any state or federal appropriations, gifts, or other moneys for use by the Commission. The duties of the Commission include organizing and coordinating efforts relating to the bicentennial celebration of the exploration of the Ozarks by Henry Rowe Schoolcraft in 1819 as well as promoting public awareness of the significance of his exploration.

The Commission shall be dissolved on June 30, 2019.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
