ASSUMPTION

Officials at the **Department of Higher Education** and the **Missouri Highway Patrol** each assume there is no fiscal impact from this proposal.

Officials at the **Northwest Missouri State University** assume a cost of \$11,298.

Officials at the **University of Missouri** assume this proposal would not have a significant fiscal impact on the University.

Officials at the **Missouri State University** assume there is no fiscal impact from this proposal.

Oversight notes this proposal defines the term affirmative consent and would require colleges and universities to provide annual awareness programming for all students and employees that includes an explanation of the definition of affirmative consent in sexual relationships. Oversight assumes this proposal would not have a fiscal impact.

Officials at the following colleges: Crowder, East Central Community College, Harris-Stowe, Jefferson College, Lincoln University, Metropolitan Community College, Moberly Area Community College, Missouri Southern State University, Missouri Western State University, Southeast Missouri State University, State Fair Community College, State Technical College of Missouri, St. Charles Community College, St. Louis Community College, Three Rivers Community College, Truman State University and the University of Central Missouri did not respond to Oversight's request for fiscal impact.
