ASSUMPTION

Officials at the **Office of the Secretary of State** assume there is no fiscal impact from this proposal.

Officials at the **St. Louis County Board of Election Commissioners** assume costs for overtime work and associated legal fees are estimated at \$12,000.

Officials at the **Brentwood** and **Parkway** school districts each assume there is no fiscal impact from this proposal to their respective district.

Oversight notes this proposal would impact school districts in St. Louis County. Those school districts are Affton, Bayless, Brentwood, Clayton, Ferguson-Florissant, Hazelwood, Jennings, Kirkwood, Ladue, Lindbergh, Maplewood-Richmond Heights, Mehlville, Normandy, Parkway, Pattonville, Ritenour, Riverview Gardens, Rockwood, Special School District of St. Louis County, University City, Valley Park and Webster Groves school districts.

Officials at the following school districts: Mehlville, Pattonville, Riverview Gardens, Special School District of St. Louis County and Webster Groves school districts did not respond to **Oversight's** request for fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
