## FISCAL ANALYSIS

### ASSUMPTION

Officials at the **Department of Elementary and Secondary Education** assume there is no fiscal impact from this proposal on the Department.

Officials at the **Concordia School District** assume this would require the rewriting of the student handbooks and training of administrative staff. Retraining of staff is estimated to cost \$688 (2 hours x 5 administrators x \$60 + \$88 benefits). The district assumes this would generate an additional 5 complaint investigations annually at a cost of \$2,098. Plus the district would need additional legal services of \$840 annually.

Officials at the **Brentwood School District** assume a cost of \$19,000 for implementation and staff training.

Officials at the **Kearney** and the **Kirksville R-III** school districts each assume no impact as they already comply with the requirements of the proposal.

Officials at the **Special School District of St. Louis County** assume minimal impact.

Officials at the **Kansas City** and **West Plains** school districts assume there is no fiscal impact from this proposal.

**Oversight** notes that currently school districts are to have a policy on anti-bullying and the policy is to be printed in the student handbook. Oversight assumes this proposal is modifying the requirements of those policies and their distribution. Oversight is unable to calculate how many school districts already have anti-bullying policies in place that meet the requirements of this proposal. Oversight assumes that school districts with policies that have to be amended can do so with existing resources.

Officials at the **Joint Committee on Administrative Rules** assume there is no fiscal impact from this proposal.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet

these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

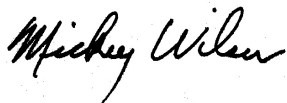
FISCAL DESCRIPTION
