Bill Summary: This proposal authorizes the Gasconade R-II School District, which crosses county boundaries, to use the county that yields the highest dollar value modifier under the school foundation formula.

FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Elementary and Secondary Education** assume to calculate the impact, the December 2016 formula calculation for Gasconade County R-II was calculated using the county they are located in that has the highest Dollar Value Modifier (DVM). As long as the formula is underfunded there would be no additional cost to the state. In this case the additional money is going to be shifted from all other school districts. If the formula is fully funded then it would be an additional cost to the State of \$1,076,885 per year.

Oversight notes the foundation formula is currently not fully funded. Therefore, in order to give the increased payment to Gasconade County R-II School District the money inside the State Money Fund (foundation formula) would be redistributed from other school districts.

Oversight notes that should the foundation formula be fully funded then General Revenue would be increased by the funding needed for Gasconade County R-II school district and the school district would receive additional funding.

Officials at the **Gasconade County R-II School District** assume this would have a positive impact of approximately \$1,076,883.

Oversight notes that DESE and the Office of Administration's Division of Budget and Planning were not able to provide Oversight with a projection of when the foundation formula may be fully funded. This proposal has a provision that may not have a net fiscal impact until such time as the formula is fully funded. Oversight, for fiscal note purposes, is showing the impact to General Revenue of this provision under the current funding of the formula (\$0) as well as if it were fully funded (\$1,076,885).

FISCAL DESCRIPTION

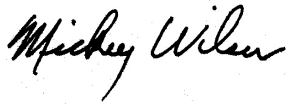
For any school district located in more than one county and whose headquarters are located within Owensville and located in more than one county, the county signified in the school district number shall be the county in the district with the highest dollar value modifier.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
