FISCAL ANALYSIS

ASSUMPTION

Oversight reviewed the Missouri Citizens' Commission on Compensation for Elected Officials report dated December 1, 2016.

The first recommendation is to change compensation payable to all members of the State of Missouri General Assembly beginning July 1, 2017 and July 1, 2018. Each member shall receive an increase in compensation of two and one half percent each year for the next two years. The percentage increase is slightly lower for leadership as the Commission recommends increasing compensation by the same dollar amount for all members in order to maintain the leadership differentials outlined in Sec. 21.140, RSMo.

Since some of the benefits paid by the state is based upon salary, an additional \$107,041 total (MOSERS contributions, employer FICA tax, long term disability, workers compensation, unemployment) for FY 2018, FY 2019 and FY 2020 would be incurred as well. Currently, the MOSERS contribution rate for state employees is roughly 19.45 percent. Therefore, the state would incur a total of roughly \$211,314 (\$176,906 + \$34,408) in FY 2018 and \$427,805 (\$358,146 + \$69,659) in FY 2019 and FY 2020 in direct additional annual expenses to fund the suggested statewide elected officials pay increases.

The total additional cost to the state of Missouri for the recommended salary adjustments to all General Assembly members is \$1,066,924 (\$211,314 + \$427,805 + \$427,805) in FY 2018, FY 2019 and FY 2020.

In addition to the recommendation of a salary increase, the daily expense compensation is to be raised by \$36.40 a day and mileage reimbursement will remain the same at \$0.37 per mile for elected officials.

The total additional cost to the state of Missouri for the recommended per diem adjustment for elected officials is \$1,489,320 (\$496,440 + \$496,440 + \$496,440) in FY 2018, FY 2019 and FY 2020.

The second recommendation is to change compensation payable to all statewide elected officials beginning July 1, 2017 and July 1, 2018.

- The compensation payable to the Governor of the State of Missouri shall be increased by \$10,706 in FY 2018 and increased by \$11,562 in FY 2019 and FY 2020, for total increase of \$22,268. This equates to approximately an 8% increase each year.
- The compensation payable to the Lieutenant Governor of the State of Missouri shall be increased by \$6,919 in FY 2018 and \$7,472 in FY 2019 and FY 2020, for a total increase of \$21,863. This equates to approximately an 8% increase each year.
- The compensation payable to the Treasurer, Secretary of State and the Auditor of the State of Missouri shall be increased by \$8,620 in FY 2018 and \$9,309 in FY 2019 and FY 2020, for a total increase of \$17,929 per elected official. This equates to approximately an 8% increase each year per elected official.
- The compensation payable to the Attorney General of the State of Missouri shall be increased by \$9,315 in FY 2018 and increased by \$10,060 in FY 2019 and FY 2020, for total increase of \$19,375. This equates to approximately an 8% increase each year.

Since some of the benefits paid by the state is based upon salary, an additional \$10,270 in FY 2018 and \$11,091 in FY 2019 and FY 2020 (MOSERS contributions, employer FICA tax, long term disability, workers compensation, unemployment) would be incurred each as well. Currently, the MOSERS contribution rate for state employees is roughly 19.45 percent. Therefore, the state would incur a total of roughly \$63,070 (\$52,800 + \$10,270) annually in FY 2018 and \$131,181 (\$109,821 + \$21,360) in FY 2019 and FY 2020 in direct additional annual expenses to fund the suggested statewide elected officials pay increases.

The total additional cost to the state of Missouri for the recommended salary adjustments to all statewide elected officials is \$325,432 (\$63,070 + \$131,181 + \$131,181) in FY 2018, FY 2019 and FY 2020.

The third recommendation is to continue the compensation structure for Missouri Judges that is being calculated under the formula in effect December 1, 2016. The salaries for the Supreme Court Judges, Court of Appeals Judges, Circuit Court Judges and Associate Circuit Judges would all be indexed to a commensurate judicial position in the federal system.

Officials at the **Office of the State Courts Administrator (OSCA)** assume there will be no changes to judges' salaries.

The recommendations made would occur as of July 1, 2017; therefore, **Oversight** will assume fiscal impact in FY 2018, FY 2019 and FY 2020.

Since this Concurrent Resolution, if passed, would nullify the pay increases scheduled to take place, **Oversight** will reflect the fiscal impact of the passage of this Concurrent Resolution as a 'cost avoidance'.

Officials at the **Missouri House of Representatives** assume there will be a cost avoidance of \$557,134 in FY 2018 and \$560,720 in FY 2019 and FY 2020.

Officials from the Missouri Lieutenant Governor, Office of the State Auditor, Missouri Senate, Office of the Secretary of State, Office of Administration, Department of Labor and Industrial Relations, Office of the Governor and Office of the State Public Defender each assume the proposal will have no fiscal impact on their respective organizations.
