ASSUMPTION

Officials from the **Department of Revenue (DOR)** state the following regarding this proposal:

§302.188.1

The proposed legislation would require individuals requesting a veteran indicator to be placed on a drivers license or nondriver license to present additional documents for verification of their discharge status.

The proposed change would require the Department to:

- Modify current driver license system edits related to the adding of a Veteran indicator;
- Modify the Uniform License Issuance Manual (ULIM) procedures related to the Veteran indicator issuance;
- Modify the Missouri Driver Guide; and
- Modify the Department's website related to documents required to obtain a Veteran indicator.

FISCAL IMPACT - Small Business

FISCAL DESCRIPTION

This proposal authorizes a person to receive a veteran designation on a driver's license or identification card upon submission of an Army or Air National Guard NGB Form 22 or World War II discharge documents showing a discharge status of "honorable" or "general under honorable conditions", a United States Department of Veterans Affairs photo identification card, or any other official form or discharge document establishing the applicant's service in the Armed Forces and discharge status other than "dishonorable", "bad conduct discharge", or "dismissed".

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
