FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration - Division of Budget and Planning** assume this proposal would exempt enhanced enterprise zones properties from property taxes for up to 25 years, provided that during the ten-year period prior to the enterprise zone expiration date, no exemption could be granted for more than ten years.

If this reduces the amount of property taxes collected, it would also reduce the amount going to the state's Blind Pension Fund, therefore reducing total state revenue. The constitutional revenue limit calculation could also be impacted.

Officials from the **Kirksville R-III School District** assume any time exemptions are made it results in a negative fiscal impact for schools.

Officials from the Office of the Secretary of State, the Joint Committee on Administrative Rules, the Department of Revenue, the State Tax Commission, Callaway County, St. Louis County, the City of Kansas City, the Jackson County Election Board, and the Platte County Board of Elections assume this proposal would have no fiscal impact on their organizations.

Officials from **Boone County**, **Johnson County**, the **Kansas City Public Schools**, and the **West Plains School District** assumed a previous version of this proposal would have no fiscal impact on their organization.

Oversight notes this proposal would limit property tax exemptions to ten years statewide, during the last ten years of authorization for the enhanced enterprise zone.

Oversight assumes the proposal would have no fiscal impact during the period covered by this fiscal note.
