FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Labor and Industrial (DOLIR)** assume they can absorb any costs relating to the creation of new correspondence types, forms and Website changes or modifications to existing forms based upon this proposal.

The legal ramifications of the proposal are unknown at this time and therefore, the effect of any judicial pronouncements and costs associated with this legislation would be seen in fiscal years beyond the fiscal note period.

The Information Technology Services Division (ITSD) assumes modifications will be made to AICS to accommodate the purposed change. It is assumed that every new IT project/system will be bid out because all ITSD resources are at full capacity.

ITSD estimated 891 hours at \$75 per contract hour, or \$66,825 in FY2019, \$13,699 in FY2020, and \$14,041 in FY2021.

Officials at the **City of Kansas City** assume the proposal will have a significant impact on the City, as well as they have the largest number of firefighters in the State of Missouri and they are all exposed to hazardous substances during the course and scope of their occupational duties. The workers' compensation costs for medical care, wage loss payments and payments for permanent partial or permanent total disability will increase substantially.

Officials from the **City of Springfield** assume the proposal has a potential negative fiscal impact. The impact is unquantifiable without knowing the increase with respect to the number of persons who will be diagnosed as having an occupational disease, as described by statute, however, the loss is likely more than \$100,000.

Officials from the **Department of Public Safety-Division of Fire Safety**, **Department of Public Safety-Missouri Highway Patrol**, **Office of Administration-General Services** and **Department of Corrections** each assume the proposal will have no fiscal impact on their respective organizations.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This act modifies provisions relating to workers' compensation for firefighters.

Under current law, certain diseases of the lungs and heart may be recognized as occupational diseases for the purposes of workers' compensation laws and are defined to be a disability for paid firefighters. This act modifies that provision to include volunteer firefighters.

Under this act, cancer contracted by a firefighter shall be presumed as an occupational disease under the following circumstances:

The firefighter is a paid or volunteer firefighter who has been assigned to at least 5 years of hazardous duty as a firefighter;

The firefighter was exposed to an agent classified by the International Agency for Research on Cancer, or its successor organization, as a group 1 or 2A carcinogen, or is classified as a cancer causing agent by a designated entity;

Twenty years have not elapsed since the firefighter was last assigned to hazardous duty as a firefighter; and

The firefighter is not 70 years of age or older at the time of the diagnosis of cancer.

This presumption may be rebutted.

FISCAL DESCRIPTION (continued)

This provision shall only apply to claims filed on or after August 28, 2018.

The act requires the Division of Workers' Compensation to prepare a biennial report on claims of cancer as an occupational disease. The initial report shall be made no later August 28, 2020.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
