## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Public Safety (DPS)** assume they will be able to absorb the cost of developing and posting the hotline posters on their website. For those establishments that request a poster be mailed to them, DPS will set in place a fee to charge the establishment that would cover the cost of printing and mailing first class. DPS assumes no fiscal impact.

**Oversight** assumes a minimal amount of costs and reimbursement revenue to DPS from this proposal and will not reflect it in the fiscal note.
