FISCAL ANALYSIS

ASSUMPTION

The **Missouri Senate** anticipates this bill would commit 5 Senate Members to the Joint Committee on the Transition of the St. Louis Public School District. The fiscal impact is unknown due to not knowing the location or number of committee meetings. If costs are minimal, existing resources can be used.

Officials from the **Missouri House of Representatives** assume the proposal will have no fiscal impact on their organization. Joint committee expenses are typically covered using the Senate's joint contingent expenses appropriation.

Officials from the **Department of Elementary and Secondary Education** and the **Office of Administration** assume the proposal will have no fiscal impact on their organizations.

Oversight assumes this proposal creates the Joint Committee on the Transition of the St. Louis Public School District with a mission of considering and making recommendations on transitioning the St. Louis Public School District from the Special Administrative Board back to an elected school board. The joint committee shall terminate by December 31, 2018 or by a majority vote of the committee, whichever occurs first.

Oversight notes the committee is composed of ten members. If all ten members attend eight meetings at a cost of \$275 per member per meeting, the total cost is estimated at \$22,000. Oversight notes the Senate Revolving Fund has a current balance of \$38,555. Oversight will show a cost to general revenue of \$22,000.

FISCAL DESCRIPTION

This concurrent resolution establishes the Joint Committee on the Transition of the St. Louis Public School District. The Joint Committee shall be composed of 5 members of the Senate and 5 members of the House of Representatives, with not more than 3 from each chamber being from the same party, as well as the members of the Special Administrative Board and the elected school board of the St. Louis Public School District. The Joint Committee may hold hearings and prepare a report with its recommendations, for submission to the General Assembly by December 31, 2018, at which time the Joint Committee shall be dissolved.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
