FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State** assume the proposal will have no fiscal impact on their organization.

Officials from the **Office of Prosecution Services** assume the proposal will have no measurable fiscal impact on their organization.

Officials from the Office of the Governor, Missouri Ethics Commission, Missouri Tax Commission, Office of the State Treasurer, and Department of Revenue each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the Jackson County Election Board, Platte County Board of Elections, and St. Louis County Election Board each assume the proposal will have no fiscal impact on their organization.

Officials from the **Kansas City Election Board** assume the proposal would have minimal (<\$1,000 per election) on their operations.

Oversight notes section 115.124 would allow cities, towns, or villages with less than 2,000 inhabitants to skip local elections if the number of open seats equals the number of candidates running for those seats. We are unable to determine the number of cities, towns, or villages that would not participate in those elections; therefore, Oversight will show the fiscal impact to the Local Election Authorities (LEA) as a savings of \$0 or Unknown.

Officials from **St. Louis County** assume the proposal will have no fiscal impact on their organization.

Officials from the **City of Kansas City** assume the provisions of section 321.320 could have a negative impact on Kansas City if Platte County increases its population to 150,000 and the Kansas City were to annex property in such county because Kansas City could not provide fire protection and EMS services to such annexed area.

Officials from the **City of Columbia** assume the proposal will not have a direct, immediate fiscal impact on their organization but state there are variables. Sec. 321.320 double taxes property owners living in annexed areas within the City of Columbia and who formerly received their service from the fire district. The City is obligated to serve citizens within its corporate boundaries, including providing fire service. Thus, some citizens will pay a fire district property

tax and levy for debt in addition to City property tax, so they will feel the immediate impact.

Two fire codes will be enforced, and they are not the same. If regulatory uncertainty is resolved through litigation, the City could face additional costs. If the City and the fire district negotiate an agreement and it is approved by both governing bodies, the City could face additional costs if it agrees to compensate the district at some level.

Oversight assumes section 321.320 of this proposal allows the City of Columbia and the Boone County Fire Protection District to continue service as usual for properties annexed by Columbia. Oversight will assume the property taxes (and fire protection services) will continue to apply to the fire protection district and that the continuance of revenue to the fire protection district (and continuance of fire protection) will be offset by a loss (and not a start of fire protection) by the City of Columbia. Oversight assumes the net impact to local political subdivisions will offset.

Officials from the **State Technical College of Missouri**, **University of Missouri**, and **Missouri State University** both assume the proposal will have no fiscal impact on their organization.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill changes elections laws. In its main provisions, the bill:

- (1) Requires the Department of Revenue to issue an annual report listing sales and use taxes authorized by state law and collected by the department (Section 32.315, RSMo);
- (2) Expands the existing exception for small cities, towns, and villages under Section 115.124, which allows candidates for election to assume office without holding an election if a particular election is uncontested and the number of candidates available equal the number of open positions, from cities, towns, or villages with 1,000 or less persons to those with 2,000 or less persons (Section 115.124);
- (3) Requires the Secretary of State to furnish specified absentee ballot information upon request of a duly authorized campaign or political party committee representative. The records include voter names and addresses and may be in an electronic format unless otherwise requested. Fees for copying may be charged and will not exceed public record copying charges (Section 115.157); and

FISCAL DESCRIPTION (continued)

(4) Requires specified fire protection districts in Clay County to continue service to residents annexed by a municipality and requires annexation costs to be borne by the municipality. Residents in a new, annexed area may serve on fire protection district boards. A sales tax may be levied upon voter approval after the annexation to provide revenue to the fire protection district. Certain cities are exempt from these requirements as specified in the bill (Section 321.320). This provision has an emergency clause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
