FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol**, the **Department of Corrections**, and the **Office of Prosecution Services** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Office of the State Courts Administrator (OSCA)** state the proposal may cause some impact, but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

For the purpose of this proposed legislation, officials from the **Office of State Public Defender** (**SPD**) cannot assume that existing staff will provide effective representation for any new cases arising where indigent persons face enhanced penalties for assaulting a law enforcement animal - a new class A misdemeanor. If the animal should die, or is put out of service, the offense is enhanced to a new class C felony.

While the number of new cases (or cases with increased penalties) may be too few or uncertain to request additional funding for this specific bill, the SPD will continue to request sufficient appropriations to provide effective representation in all cases where the right to counsel attaches.

Oversight assumes the OSCA and SPD can absorb the additional caseload that may result from this proposal.

Officials from the **Boone County Sheriff's Department** and the **Springfield Police Department** each assume the proposal would not fiscally impact their respective agencies.

Officials from the Columbia Police Department and the St. Louis Metropolitan Police Department did not respond to **Oversight's** request for fiscal impact.
