FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State (SOS)** assume the proposal will have no fiscal impact on their organization.

Officials from the **Missouri Senate** assume the proposal as written could anticipate using existing resources if the impeachment occurred during regular legislative session. If a special session were called for the purpose of an impeachment the Senate would anticipate a fiscal impact of \$9,500 per day.

Oversight notes that the Missouri Senate could potentially have a cost ranging from \$9,500 - \$570,000 (\$9,500 x 60 days) if a special session were called for the purpose of an impeachment. This range is based on the SEN estimate of \$9,500 per day and that a special session cannot exceed 60 days.

Officials from the **Attorney General's Office** assume that any potential costs arising from this proposal can be absorbed with existing resources. Attorney General's Office may seek additional appropriations if there is a significant increase in litigation.

Officials from the Missouri House of Representatives, Office of State Courts Administrator, Office of the Governor, and Missouri Lieutenant Governor each assume the proposal will have no fiscal impact on their respective organizations.

FISCAL DESCRIPTION

Currently, the impeachments of certain public officials are tried before the Missouri Supreme Court, except that the impeachment of a Governor or member of the Missouri Supreme Court is tried before a special commission. This proposal provides that all impeachments shall be tried by the Missouri Senate, except for the impeachment of a Governor, which shall be tried by the Chief Justice of the Missouri Supreme Court.

The provisions of this proposal are contingent upon the passage of a constitutional amendment that provides for the same changes to impeachment trials.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
