## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Insurance, Financial Institutions and Professional Registration** state that it is unknown what professions may be affected by this legislation in the future. Therefore, the fiscal impact to their department is unknown.

**Oversight** assumes this proposal establishes guidelines for the regulation of professions not now regulated. The fiscal impact for specific professional regulations will be reflected in the enabling legislation.

Officials from the **Department of Revenue, the Department of Health and Senior Services, the Department of Natural Resources** and the **Department of Agriculture** each assume the proposal will have no fiscal impact on their respective organizations.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
