FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Transportation (MoDOT)** assume MoDOT would be compelled to purchase an unknown, but significant amount of right of way. The fiscal impact is unquantifiable at this time; however, it would be significant considering the number of centerline miles of highway in the state.

Oversight will reflect a cost of \$0 or a negative Unknown to the State Road Fund to account for the purchase of land if required.

Officials from the **Department of Economic Development - Division of Energy**, **Missouri Public Service Commission**, and **Office of Public Counsel** each assume the proposal will have no fiscal impact on their respective organizations.

FISCAL DESCRIPTION

This act requires that the Department of Transportation utility corridor be 12 feet wide. The location, construction, maintenance, removal, and relocation of any utility facility under this act shall be at the expense of the utility facility owner.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
